OBEDIENCE / RALLY REFUNDS & TRANSFERS

Bitches in Season: Females in season are not permitted to compete. If a female is withdrawn from competition because it came into season, and the event secretary is notified no later than one half hour prior to the start of the first class in the trial, a full refund will be due the exhibitor.

Transfers (formerly called move-ups): After a dog earns a title, it may be transferred to another class in a future trial, even though the closing date for the trial has passed. A transfer (i.e., from an obedience class to an obedience class or a rally class to a rally class) may be requested if, according to the owner's records the handler and dog are eligible and the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. Movement between an "A" and "B" class at the same level is not considered a transfer – refer to Chapter 1, Section 16b.

ROUTES TO THE SHOW

From South: Take Highway 45 North to County Highway PV. Exit East on PV; entrance to Fair Park will be immediately on the left.

From North Take Highway 41 South to County Highway 60. Go East on Highway 60. Go North on Highway 45. Exit East on PV; entrance to Fair Park will be immediately on the left.

UNLOADING & PARKING

We are in the Ziegler building this year. The best place to unload and closest to the grooming area is on either side of the overhead door. As you are facing the Ziegler Building, follow the road to the right of the building to a gravel parking lot. Alternately you can use the front entrance.

Please be courteous of all who need to unload; as soon as you are done, and **before setting up**, please move your vehicle to the parking lot in front of the Ziegler building. Parking in front of the doors will not be allowed.

Set up is Thursday from 4-8 pm. On Friday and Saturday, the building will be open from 6:30 am to 7:00 pm

SET-UP & GROOMING

**Show Site will be available to exhibitors from 4:00 – 8:00
on Thursday, February 27, 2020.**

Day Crating ~ there will be a reserved area for day crating & unpaid grooming; however, **NO ELECTRICAL** service is in that area. **Reserved Grooming** ~ Reservation form in the premium. \$25 for an 8 x 8 space for both days. Includes electrical service; please bring your own extension cords.

No dogs may be left overnight in the building

FOOD

Lunch will be available for purchase both days.

NOTE: There will **NOT** be a scheduled lunch break in judging on either Friday or Saturday. Please plan accordingly.
